Summary Annual Report for SHEET METAL WORKERS LOCAL 265 PENSION FUND

This is a summary of the annual report for SHEET METAL WORKERS LOCAL 265 PENSION FUND, EIN 36-6168611, Plan Number 001, for the period July 1, 2001 to June 30, 2002. The annual report has been filed with the Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided through insurance and through a trust fund. Total plan expenses were \$4,334,800. These expenses included \$783,446 in administrative expenses and \$3,551,354 in benefits paid to participants and beneficiaries. A total of 2,700 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$126,226,944 as of June 30, 2002, compared to \$127,367,935 as of July 1, 2001. During the plan year the plan experienced a decrease in net assets of \$1,140,991. This decrease includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$3,193,809 which included employer contributions of \$8,785,268, a gain of \$516,958 from the sale of assets and losses from investments of \$6,108,417.

Minimum Funding Standards

An actuary's statement shows that enough money was contributed to the plan to keep it funded in accordance with the minimum funding standards of ERISA.
